

**LUBBOCK-COOPER INDEPENDENT SCHOOL DISTRICT
SCHOOL BOARD MINUTES FOR THE 2025-26 SCHOOL YEAR**

10-16-25

1. Call to Order:

President Paul Ehlers called to order the regular meeting of the Lubbock-Cooper ISD Board of Trustees at 7:00 p.m. in the LCISD Administration Office Board Room, announced a quorum was present, that the meeting had been duly called and that notice of the meeting had been posted in the time and manner required by law. Other Board members present were Daniel Castro, Colby Miller, Koley Schaffner, and Trey Strong.

2. Student Spotlight:

A. The Board recognized Campus Students of the Month who were introduced by instructional personnel from Lubbock-Cooper North Elementary and Principal Whitney Tarrant. Each student was presented with a certificate by Board Member Trey Strong and Superintendent Aaron Waldrip.

3. Campus Spotlight: Principal Whitney Tarrant recognized Lubbock-Cooper North Elementary as Campus Spotlight and presented a short video highlighting North as an Apple Distinguished School.

4. Apple Distinguished Campus Recognition – Apple Account Executive Beau Maine recognized North Elementary as an Apple Distinguished Campus. North Elementary was awarded this recognition for their Centers of Excellence, Apple 1 to 1, Showcasing Technology and their ability to Inspire, Imagine and Impact.

5. Public Comment: Mr. James Harris addressed the Board regarding concerns with the Lubbock Central Appraisal District.

A. Superintendent: Aaron Waldrip reported various positives in the district with LCISD technology department and athletic sportsmanship getting recognition within the community.
